In the year 1992 Degree college with Arts faculty and in the year 1995 Commerce faculty was started. Post-Graduation Course stated in 2016 with M.Com. in Business Management. Moreover New English School was established in Talavali village in the year 1972. At present Shri. Bhalchandra Raghunath Chavan is the president of the Society and is ably guiding the society since 1989. At present, the institution being run by Patpanhale Education Society.

Ratnagiri (M.S.) established in the year 1962, took permission from the Government of Maharashtra to start its Patpanhale Arts, Commerce and Science College in the year 1992. The college is located at Patpanhale-Shringartali, Tal. Guhagar, Dist. Ratnagiri (M.S.). It is affiliated to the University of Mumbai. Initially the management started its Arts Programme and later on Commerce Programme with nine academic departments (Marathi, Foundation Course, English, Political Science, Rural Development, History, Economics, Commerce and Accountancy). Almost all students are from rural areas and around 50% of them are from socially backward and downtrodden sections of the society. Girl students are around 55%. It is a common feature of the parents and the students that after passing 12th standard examination, students either go to Mumbai for jobs or discontinue their education. The management and the staff of the college have been taking very hard and sincere efforts to attract them for getting higher education. Consequently, we achieved a lot in this direction. We work always in the direction towards our vision, mission, objectives and values set for enhancement of quality education.

In the long way of advancement, the college has attained certain landmark achievements such as assessed and accredited by the NAAC, Bangalore with C++ grade in the year 2004, getting permanent affiliation from University of Mumbai in 2007-08, enlisting the college under sections 2(f) and 12(b) of the UGC Act and then assessed and accredited by the NAAC with B Grade in December 2013 and the college is in the process of getting accreditation for 3rd cycle in 2020-22. The college has arranged a number of activities for the upliftment of students and the staff. It has also started Post Graduate Programme (M.Com. in Business Management) in the year 2016. The college has also started a centre of Open University for students from educationally deprived sections of the society. The college has about 43 Cells and Associations for the development of the students. A number of faculty members are pursuing research work leading to Ph.D. Degree. The teachers have undertaken several research projects funded by University of Mumbai. The college has been shifted in the new building since 27th November, 2019. In all our endeavors, Hon. Shri. Impact of F.D.I. on Retail Business in India

Foreign investment was introduced in 1991 as Foreign Exchange Management Act by then Finance Minister of India, Mr. Manmohan Singh. As Singh subsequently became a prime minister, this has been one of his top political problems. Most of the oppositions disallowed overseas corporate bodies to invest in India. The fast and steadily growing economy of India in majority of its sectors, has made India one of the most famous and popular destinations in the whole world, for Foreign Direct Investment. India's ever- expanding markets, liberalization of trade policies, development in technology and telecommunication, and loosening of diverse foreign investment restrictions, have further collectively made India, the apple of investors' eye, for most productive, profitable, and secure foreign investment. According to a recent survey by the United Nations Conference on Trade and Development (UNCTAD), India has conspicuously emerged out as the second most popular and preferable destination in the entire world, after China, for highly profitable foreign direct investment. In recent years, bulk of the foreign direct investment in Indian business sectors of infrastructure, telecommunication, information technology, computer hardware and software, and hospitality services, have been made by investors of countries like US, UK, Mauritius, Singapore, and many others. Amount of FDI (from April 2000 to July 2012) into India stood at US\$ 176.76 billion. India is the 3rd largest economy of the world in terms of purchasing power parity and thus looks attractive to the world for FDI. Even Government of India, has been trying hard to do away with the FDI caps for majority of the sectors, but there are still critical areas like retailing and insurance where there is lot of opposition from Indians. Some of the major economic sectors where India can attract investment are as Telecommunications, Apparels and Information Technology etc. 7th December 2012, FDI cleared all its entry barriers in the India market with support of UPA government. There was a voting poll conducting the parliament sessions, where Mayawati and Mulayam Singh clearly boycotted the voting panel hence making an easy way out for the government. This poll was conducted on the basis of having Wal-Mart and Tesco as the local market outlets in India. Foreign Direct Investment, will change the scenario of the Indian market now you would be able to have products at the cheapest rates, you would have the Coke and Pepsi outlet in your colony. This will definitely affect the other retailers and the middle men in the business of transportation and those who were dependent on the retail market on 7th was legalized. The guidelines are drawn and the December FDI foreign companies need to stick to these lines in order to productively carry out their company outlets in the Country. The MRP's will be decided and foretold by the government. The companies will be asked to have maximum employees.

Need of FDI

- 4) If the investors are interested in investing in the infrastructure sector they are welcome because by this they will leave something for the host even if they claim that they are not interested afterwards, but investors in this sector are very less.

- Small enterprises fear that they may not be able to compete with world class large companies and may ultimately be edged out of business. Large giants of the world try to monopolies and take over the highly profitablesectors;
- Such foreign companies invest more in machinery and intellectual property than inwages of the local people;
- Government has less control over the functioning of such companies as they usually work as wholly owned subsidiary of an overseas company;
- All the middle men workers will face a drastic loss
- There are around 23 core of people who are currently engaged in the middle menbusiness will be jobless
- Indians are generally dependent on this broker business, unemployed people usuallyopt this way out and hence most of the Indian employers will face "no jobs"
- All the transport and profiting business will decline
- What will be the situation of Retailers who are presently running their small business, they will be out, will not be able to compete with big businesses.
- Employment will be only for educated what about India's uneducated people as Indiais not a country where everyone's is educated.
