In pursuance of clause (3) of article 348 of the Constitution of India, the following translation in English of the Maharashtra Public Universities Act, 2016 (Mah. Act No. VI of 2017), is hereby published under the authority of the Governor.

MAHARASHTRA ACT No. VI OF 2017

(First published, after having received the assent of the Governor in the "Maharashtra Government Gazette", on the 11th January 2017).

An Act to provide for academic autonomy and excellence, adequate representation through democratic process, transformation, strengthening and regulating higher education and for matters connected therewith or incidental thereto.

WHEREAS it is expedient to provide for academic autonomy to non-agricultural and non-medical universities in the State of Maharashtra and to make better provisions therefor;

AND WHEREAS the Government of Maharashtra had appointed committees under the Chairmanships of Dr. Arun Nigvekar, Dr. Anil Kakodkar, Dr. Ram Takwale and Late Mrs. Kumud Bansal with a view to consider and recommend on different aspects of higher education and learning and to suggest various measures to ensure such autonomy;

(१)

(11) "collaboration" means collaborative academic activity of the university or college or institution with other universities, academic institutions including local, regional, national or international institutions, research institutions and organizations in the field of agriculture, industry, trade and commerce, sports, social, cultural, science, technology and any other field ;

(12) "college" means a college affiliated to the university, situated in the university area or jurisdiction ;

(13) "College Development Committee" means the College Development Committee constituted under section 97 of this Act ;

(14) "Collegium of Heads of Department of Affiliated Colleges and recognized institutions" means an electoral college consisting of heads of departments from affiliated colleges and recognized institutions who shall elect from amongst themselves as members to the concerned authorities;

(15) "Collegium of Graduates of the University" means an electoral college consisting of registered graduates of the university, who shall elect from amongst themselves as members to the different authorities ;

(16) "Collegium of Management Representatives" means an electoral college consisting of representatives of management committees of affiliated or autonomous colleges or institutions who shall elect from amongst themselves as members to the different authorities ;

(17) "Collegium of Principals" means an electoral college consisting of fulltime approved Principals and Directors of recognized institutions who shall elect from amongst themselves as members to the different authorities ;

(18) "Collegium of Teachers" means an electoral college consisting of fulltime approved teachers from affiliated and autonomous colleges and recognized institutions, who shall elect from amongst themselves as members to the different authorities ;

(19) "Collegium of University Teachers" means an electoral college consisting of fulltime teachers from University Departments, University Institutions, and Conducted Colleges appointed by university who shall elect from amongst themselves as members to the different authorities ;

(20) "Commission" means the Maharashtra State Commission for Higher Education and Development constituted under section 76 of this Act;

(21) "community college" means an institution providing skill-based academic programs as prescribed in the Statutes ;

(22) "conducted college" means a college maintained and managed by the university ;

(23) "De-notified Tribes (Vimukta Jatis)" means tribes declared as such by the State Government, from time to time;

(24) "department" means a department teaching a particular subject or a group of subjects in a college or an institution as prescribed in the Statutes;

(25) "Director" means a head of an institution including a centre or a school of the university as designated by the Management Council or a head of a recognized institution;

(26) "Director of Higher Education" and "Director of Technical Education" means respectively, Director of Higher Education, Maharashtra State and Director of Technical Education, Maharashtra State;

97. (1) There shall be a separate College Development Committee for every affiliated, autonomous, empowered autonomous college or recognized institution, consisting of the following members, namely :- College Development Committee.

- (a) Chairperson of the management or his nominee ex-officio Chairperson ;
- (b) Secretary of the management or his nominee ;
- (c) one head of department, to be nominated by the principal or the head of the institution ;
- (d) three teachers in the college or recognized institution, elected by the full-time amongst themselves out of whom atleast one shall be woman ;
- (e) one non-teaching employee, elected by regular non-teaching staff from amongst themselves ;
- (f) four local members, nominated by the management in consultation with the principal, from the fields of education, industry, research and social service of whom at least one shall be alumnus;
- (g) Co-ordinator, Internal Quality Assurance Committee of the college ;
- (h) President and Secretary of the College Students' Council;
- (i) Principal of the college or head of the institution - Member - Secretary.

(2) For a college or institution managed and maintained by the State Government, the College Development Committee shall consist of the following members, namely:-

- (a) Principal of the college or head of the institution - Chairman.
- (b) Joint Director designated by the Director of Higher Education, ex-officio Member ;
- (c) three teachers in the college or recognized institutions, elected by the full-time approved teachers from amongst themselves;
- (d) one non-teaching employee, elected by the regular non-teaching staff from amongst themselves ;

(e) four local members, nominated by the Director of Higher Education in consultation with the principal, from the fields of education, industry, research and social service and having minimum post-graduate degree of whom at least one shall be alumnus;

- (f) Co-ordinator, Internal Quality Assurance Committee of the college, ex-officio;
- (g) President and Secretary of the College Students' Council ; and
- (h) one head of department, nominated by the principal or the head of the institution - Member Secretary .

(3) The College Development Committee shall meet at least four times in a year.

(4) Elected and Nominated members shall have a term of five years from the date of election or nomination. If any vacancy occurs in the office of such member, the vacancy shall be filled within three months by the Principal and the member so appointed shall hold office for the residual term for which the earlier member shall have held the office if the vacancy had not occurred.

(5) The College Development Committee shall,-

(a) prepare an overall comprehensive development plan of the college regarding academic, administrative and infrastructural growth, and enable college to foster excellence in curricular, co-curricular and extra-curricular activities ;

(b) decide about the overall teaching programmes or annual calendar of the college ;

(c) recommend to the management about introducing new academic courses and the creation of additional teaching and administrative posts ;

(d) take review of the self-financing courses in the college, if any, and make recommendations for their improvement ;

- (e) make specific recommendations to the management to encourage and strengthen research culture, consultancy and extension activities in the college ;
- (f) make specific recommendations to the management to foster academic collaborations to strengthen teaching and research ;
- (g) make specific recommendations to the management to encourage the use of information and communication technology in teaching and learning process ;
- (h) make specific recommendations regarding the improvement in teaching and suitable training programmes for the employees of the college ;
- (i) prepare the annual financial estimates (budget) and financial statements of the college or institution and recommend the same to the management for approval ;
- (j) formulate proposals of new expenditure not provided for in the annual financial estimates (budget) ;
- (k) make recommendations regarding the students' and employees' welfare activities in the college or institution ;
- (l) discuss the reports of the Internal Quality Assurance Committee and make suitable recommendations ;
- (m) frame suitable admissions procedure for different programmes by following the statutory norms ;
- (n) plan major annual events in the college, such as annual day, sports events, cultural events, etc. ;
- (o) recommend the administration about appropriate steps to be taken regarding the discipline, safety and security issues of the college or institution ;
- (p) consider and make appropriate recommendations on inspection reports, local inquiry reports, audit report, report of National Assessment and Accreditation Council, etc. ;

- (q) recommend the distribution of different prizes, medals and awards to the students.
- (r) prepare the annual report on the work done by committee for the year ending on the 30th June and submit the same to the management of such college and the university ;
- (s) perform such other duties and exercise such other powers as may be entrusted by the management and the university.

After the above-signed members attended the meeting, the meeting began its deliberations under the chairmanship of Hon. Mr. Bhalchandra R. Chavan in the cabin of the principal of the college. In the meeting, detailed discussions have been held and resolutions have been passed on the following matters.

Resolution No. 1

Sub: Reading and duly approving the minutes of the previous meeting

The minutes of the previous meeting held on 14-02-2021 were read before the meeting. A discussion was held on the same and as they all are found to be agreeable to all, they have been unanimously approved in the meeting. The resolution proposed by Mr. Deasi P. A. and seconded by Mr. Bhagwat P. S., has been unanimously passed in the meeting.

Resolution No. 2

Sub: To hold a discussion about the NAAC of the college

As per the directions of the UGC and the Government, there is a need for the college for the third cycle reaccreditation by the NAAC. In this regard, the SSR of the college and the required amount of fee have been sent to NAAC, Bangalore. Accordingly, the NAAC has given 6th and 7th September, 2021 as the dates of visit of NAAC peer team to the college. In this regard, required preparations are in progress. These preparations include- colouring of the visible portion of the college building, making all out efforts for the commencement of college canteen, purchase and installation of RO plant for making available drinking water to the college students, Installation of grill to the facial portion of the college building, preparation of ramp etc. A discussion is held to oversee the aforesaid preparations and opined that these works are to be done at the earliest and permission was also given for doing required preparations in this regard. A unanimous resolution was passed in this regard. The resolution proposed by Principal Dr. R. G. Jadhav and seconded by Prof. K. R. Shindhe, has been unanimously passed in the meeting.

Resolution No. 3

Sub: About the construction of the first floor of the college building

The construction of the ground floor of the college building has been completed. Due to leakages during the rainy season, water is being stored in all the classrooms. Therefore, there is need to construct first floor of the college building. Therefore, it has been decided to request the Society for the construction of the first floor so that the leakage-related problem can be solved and a unanimous resolution has been passed in this regard. The resolution

proposed by Mr. Sudhakar P. Chavan, the secretary of the society, and seconded by Prof. Mr. Gajbhiye L. M., has been unanimously passed in the meeting.

Resolution No. 4

Sub: Sub: About appointment of teachers in the college on Clock Hour Basis (CHB)

The is a need of appointment of teachers on Clock Hour Basis (CHB) in the college for the academic year 2021-22 in the subjects of Marathi, Environmental Studies, English, and Maths. In this regard, No Objection Certificate (NOC) has been obtained from the Government a proposal has been sent to the University for the approval of advertisement. After approval of the advertisement by the University, the same will be published in the paper, interviews will be held and suitable candidates will be selected. A unanimous resolution was passed in the meeting. The resolution proposed by Dr. Shindhe K. R. and seconded by Sou. Sansare S. S., has been unanimously passed in the meeting.

Resolution No. 5

Sub: Purchase of essential things required for different departments of the college

There is a need to purchase different things required for different departments of the college like- Gymkhana, Cultural Department, N. N. S. Department, Library Department, IQAC, Office and also for administrative and other purposes. A discussion is held in this regard and unanimously resolved in the meeting to purchase essential things. The resolution proposed by Sou. Sansare S. S. and seconded by Mr. Bhagwat P. S., has been unanimously passed in the meeting.

Resolution No. 6

Sub: About discussion on administrative activities relating to admission of students in the college and formulation of plans relating thereto

A detailed discussion was held on the students to be admitted to in the college for the academic year 2021-22 and the administrative planning to be made in connection with work to be done in this regard and discussions were held on the following matters-

- 1) The admission for S Y /T Y, B A & B Com classes has been commenced from 15th June, 2021 and admissions are being given to the students according to the convenience of the students.

- 2) Online classes have been started from 24th June, 2021 and information relating thereto has been posted on different WhatsApp groups for the information of the students. The response of the students is very encouraging in this regard.
- 3) For improving educational standard, the teachers of the college have prepared and submitted their subject planning, workload, planning of 32 Yips, planning of cells and association etc.
- 4) The results of 2nd & 4th Semester classes of F Y & S Y B A & B Com classes have been declared on 31st May, 2021. Students are taking their mark sheets according to their convenience.
- 5) The ATKT examinations of F Y & S Y B A & B Com classes were held in the month of May, 2021. The results of these examinations were declared on 17-06-2021.
- 6) The examinations of T Y B A B Com (in online mode) were held during 05-05-2021 to 17-05-2021.
- 7) Examinations of M Com class are going to start from 22-07-2021 and instructions have been given for making in this regard.
- 8) The examinations of Yashwantrao Chavan Maharashtra Open University, Nashik from 11-08-2021.

Discussions were held on the above matters and unanimous decision was taken for appropriate planning relating thereto. The resolution proposed by Prof. Gajbhiye L. M. and seconded by Prof. Shindhe K. R., has been unanimously passed in the meeting.

Resolution No. 7

Sub: About creation of WhatsApp Groups of different classes (of students) of the college

Keeping in mind the COVID pandemic situation, it seems that, the Government is not going to allow to run the classes in the college. In view of this, for communication with the students (who have taken admission for the academic year 2021-22) and also for conducting online classes, it has been decided to create class-wise WhatsApp Groups. For this, a unanimous resolution is passed in the meeting. The resolution proposed by Principal of the college, Dr. R. G. Jadhav and seconded by Mr. P. A. Desai, has been unanimously passed in the meeting.

Resolution No. 8

Sub: Purchasing of books for the college library for the academic year 2021-22

There is a need of purchasing books of different subjects, being taught in the college, for the academic year 2021-22. Similarly, there is also need of purchasing essential books for the M. Com. Programme also. It is opined in the meeting that more preference be given for the purchase of reference books. In addition to this books relating to general knowledge and knowledge-oriented (for students) should also be purchased. In this regard, a unanimous resolution is passed. The resolution proposed by Dr. Khot S. S. and seconded by Mr. Bhagwat P. S., has been unanimously passed in the meeting.

Resolution No. 9

Sub: About arranging seminars by the teachers on different subjects and making attempts to research-related activities

In the meeting it is felt that, all the teachers working in the college should make efforts for arranging webinars on their respective subjects and also make efforts for undertaking research on socially useful fields and a unanimous resolution is passed in this regard. The resolution proposed by Principal Dr. R. G. Jadhav and seconded by Mr. Sudhakar P. Chavan, has been unanimously passed in the meeting.

Resolution No. 10

Sub: About the promotion of teachers and other staff of the college

- 1) The pay fixation of Dr. D. Y. Parkhe, Assistant Professor in the subject of Economics in respect of Stage-1 to Stage-2 has been got done from Hon. Joint Director, Higher Education, Konkan Division, Panvel. Proposal will be sent to Hon. Accounts Officer for verification.
- 2) Proposals of Prof. L. M. Gajbhiye and Prof. K. R. Shindhe for placement from Stage-3 to Stage-4 have been sent for approval to the University.
- 3) A committee has been formed by the University for the Placement of Mr. Dhananjay Dattatray Gurav, the librarian of the college, from stage-1 to stage-2. Necessary work will be done for his placement after considering and taking time convenient to Hon. Joint Director.

Resolution No. 11

Sub: About admission process in to first year in the college after declaration of 12th standard result

It is required to start admission process of first year classes after declaration of 12th standard results. For that, in the meeting, it is resolved that, efforts should be made to get contact numbers and other information by contacting our junior and other nearby junior colleges, contacting the students and thereby by encouraging them to get admission in our college and a unanimous resolution is passed in this regard in the meeting. Similarly, there is a need to get affiliation from the University for admission into of F Y B Sc. Class. It has been decided in the meeting to start admission process for that class after getting affiliation from the University. The resolution proposed by Mr. Sudhakar P. Chavan and seconded by Mr. Desai P. A., has been unanimously passed in the meeting.

Resolution No. 12

Sub: About commencement of science faculty in the college from the academic year 2021-22

A proposal has been submitted by the Society, to the Government through the University, for the commencement of science faculty in the college from the academic year 2021-22. For that, the approvals of the University and the Government have been received. As per the rules of the Government, the No Objection Certificate (NOC) has been obtained from the Government after getting done the verification process of the college. The proposal has been sent for getting the affiliation of the University. After getting affiliation from the University, the science faculty will be started in the college and a unanimous resolution is passed in the meeting in this regard. The resolution proposed by Principal Dr. R. G. Jadhav and seconded by Mr. Khot S. S., has been unanimously passed in the meeting.
